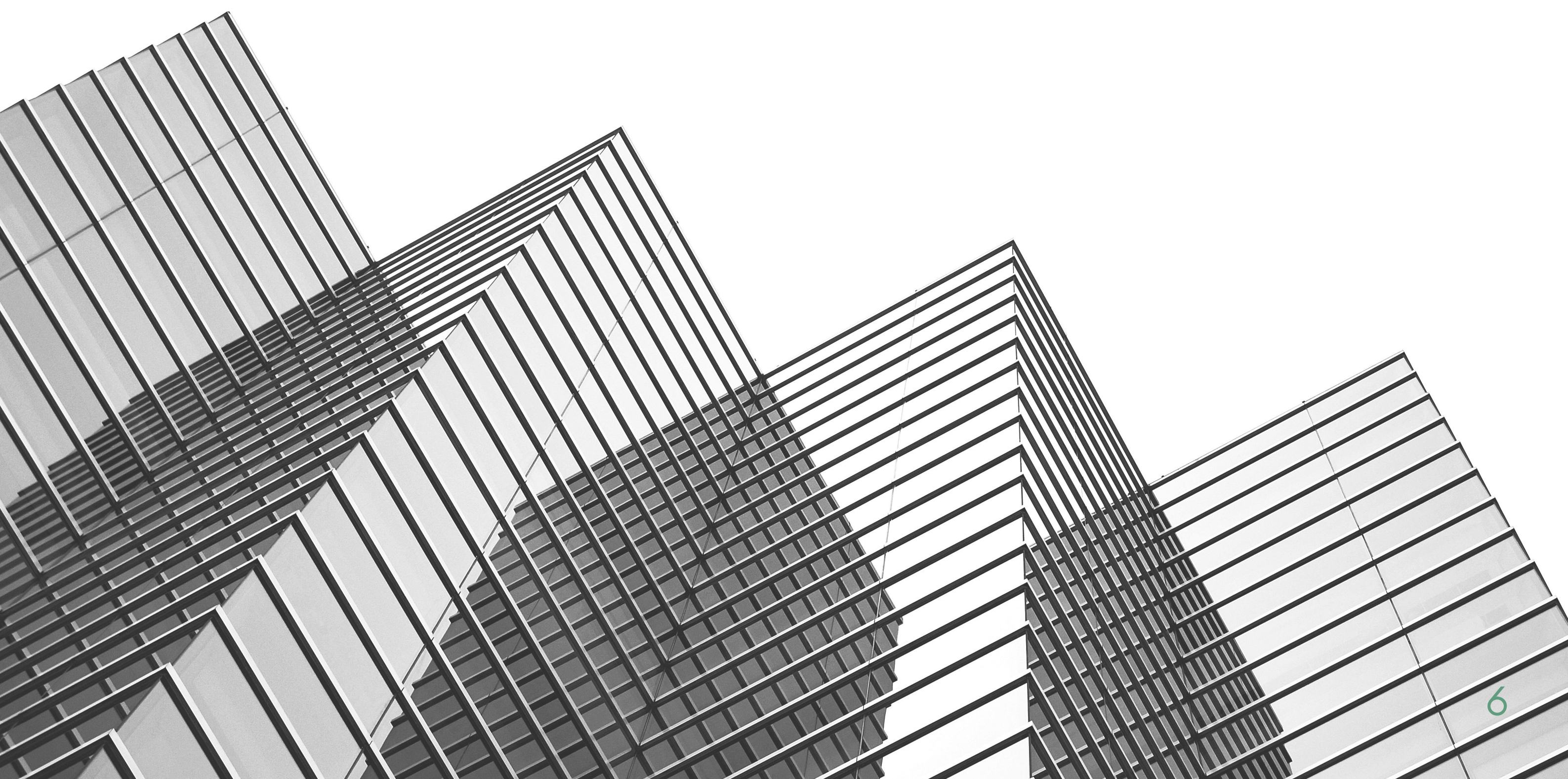
Study Management Accounting (P1) and Advanced Management Accounting (P2).
